**General Terms and Conditions**

In consideration of allowing the declared child/children to participate in babysitting activities, the undersigned, for themselves, and/or being the legal and acting guardian of participant(s), acting for themselves and on behalf of the child/children, release and hold harmless Naples Babysitting Company, LLC, its owners, employees, and agents of and from any and all injury of any nature or extent, that may be sustained by the child/children and/or the undersigned, while under the care and supervision of Naples Babysitting Company, LLC, its owners, officers, employees, or agents.

The undersigned hereby gives permission for Naples Babysitting Company, LLC, its owners, employees, and/or agents to seek emergency medical treatment for the participants in the event they are unable to reach any parent or guardian. The undersigned also agrees that they themselves will be responsible for any financial debt incurred by said action.

The undersigned on behalf of themselves and their child/children hereby choose to voluntarily enter into this agreement, knowing the risks associated with babysitting services, including, but not limited to, risks associated with transportation to and from activities and participation in activities, including, but not limited to, sports, swimming, surfing, biking, skateboarding, scootering, roller blading etc.. and hereby acknowledge and agree that said activity and the transportation to and from such activity has inherent risks associated with the transportation and participation in said activity. Prior to entering into this Agreement, the undersigned has disclosed in writing to Naples Babysitting Company, all conditions of the child/children that may affect the general health and welfare of said child/children and any limitations that the child/children may have in participating in any of the aforementioned or similarly activities. The undersigned on behalf of themselves and their child/children voluntarily assume any and all risks of loss, damage, or injury that may be sustained by the child/children and/or the undersigned by them while under the care or supervision of Naples Babysitting Company, LLC, its owners, employees, and/or agents.

By execution of this Agreement, the undersigned acknowledges:

- (a) That they have read thoroughly, understand completely the terms of this Agreement and signs it voluntarily
- (b) That the undersigned signing either for themselves, or as Legal guardian is, in fact, the true and legal guardian and has the consent of the child/children
